Gift Monthly

When you become a monthly donor, you help injured or orphaned wildlife every day by investing in their rescue and rehabilitation for as long as is necessary. Many patients stay with us for months until they are strong enough to be released.

Gift in Celebration

A meaningful, thoughtful, and unique way to celebrate a milestone or event, like a birthday or anniversary, is to donate on their behalf to wildlife.

Gift in Memory

To honour a life well-lived, help to give a future to orphaned or injured wildlife.

Gift RRSP/RRIP

A gift in your will, or adding AIWC as a beneficiary to your RRSP.

Gift Securities

Donating appreciated publicly-traded securities (stocks, income trust units, bonds, mutual funds) allows you to give more and make a bigger impact to wildlife, as the capital gains tax does not apply.

A gift in your will, or adding AIWC as a beneficiary to your life insurance.
